## UBNJ Deer Management Hunting Application

- Applicant must be current individual UBNJ member in good standing with membership valid through the Winter bow season of any year hunt applied for; thus being covered by UBNJ insurance.
- All applicant must pass UBNJ safety/orientation proficiency qualification prior to hunting individual programs.
- Applicant must be at least 18 years of age & possess applicable valid hunting & drivers licenses as well as a valid NJ Firearms ID card. (NJ Firearms ID card mandatory Jan. 2008) or letter from PD showing clean record.
- Applicant must read & sign attached Certificate of Eligibility (page 3) and any Additional Requirements form.
- All applicants must provide a valid phone number or email address that will allow the hunt manager to contact the participant and respond within 24 hours.
- Applicants can apply annually for no more than one hunt per year.
- Applicants will be selected by lottery style drawing.
- All information below is CONFIDENTIAL to UBNJ & Hunt Administration only. Information will not be shared with anyone outside the program.
- UBNJ application period will be after the hunt has been posted until the posted deadline date or hunter allotment has been reached.

## Certificate of Eligibility

Any applicant who is prohibited by law or court order from possessing a firearm or weapon of any type, who has been convicted of a felony or indictable crime, who within three years of the date of this Certification has committed any violation of New Jersey Fish and Wildlife Law or Regulation Codes, or who has violated any local regulation or ordinance pertaining to hunting or to parks, shall not be eligible for this Deer Management Hunting Program.
